<b>Description of Change</b>	TT Electronics is announcing that the PHS11 Series is being taken End of Life, (EOL). This applies to all variants of the series. An example of a generic part number can be found in Appendix 1.
<b>Reason for Change</b>	Declining demand and supply chain issues means it is no longer possible to supply these products.
<b>Implementation Plan</b>	All part numbers are end of life with immediate effect and no Last Time Buy is possible.
<b>Customer Impact</b>	All part numbers are EOL and unavailable for order or delivery with immediate effect. However a replacement series exists and drop in replacements can be ordered by changing part numbers starting PHS11-1 to PHS11R2.
<b>Recommendations</b>	Please contact your local Sales / FAE team for assistance in selecting the best alternative product. TT Electronics recommend PHS11R2 as a drop in alternative.
<b>Availability of Previously Manufactured Product</b>	N/A
