These products are designed and manufactured with Precious Metal and Rare Earth Metals.

The market price of these materials continues to increase affecting product cost and profitablity.

In addition, it may be difficult to obtain a stable supply of these materials in the future.

Smaller case sizes such as the 0201 and 0402 have been developed with similar capacitance:

GRM033 series: LxWxT = 0.6x0.3x0.3mm (0201 EIA) GRM155 series: LxWxT = 1.0x0.5x0.5mm (0402 EIA)

As a result, demand for these Low Profile types (GRM153/GRM15X/GRM185) has been shifting to the smaller case sizes
